

### Mahmud Tukur's memorial day

NOVEMBER 15, 1989 marks the first anniversary of the death of Dr. Mahmud Modibo Tukur.

Late Mahmud Tukur until his death last year was the Head of the History Department and the Dean, Faculty of Social Sciences, Ahmadu Bello University, Zaria.

As the former president of the proscribed Academic Staff Union of Universities (ASUU) between 1981-85, he made history when the ASUU under his leadership became the first senior staff union to affiliate with the Nigeria Labour Congress.

To commemorate the first anniversary of his death, the Committee of Friends of the late Dr. Mahmud Tukur, ABU, Zaria, whose Protem Secretary is Dr. Tanimu Abubakar of Dept. of English Plans to hold a "late Dr. Mahmud Tukur Memorial Day" on Wednesday, November 15, 1989 at the Faculty of Social Sciences (FASS) ABU, Zaria.

According to the invitation sent out by the committee, the Memorial Day is to serve as "recognition of the late Dr. Tukur's immense contributions to learning and to the struggle for democracy and social justice."

A symposium which is "The Intellectual, Democracy and Social Justice" is being organised to mark the day. The first session of the symposium will deliberate on "Labour Movement and Democratic Struggle in Nigeria." Among the speakers being expected are Alhaji Hassan Surmonu, the Secretary General of the Organisation of African Trade Union Unity (OATUU) and Dr. Attahiru Jega, former ASUU boss before it was proscribed last year. Comrade Pascal Bafyau, NLC president will be the Chairman of this session.

The afternoon session will discuss the "Prospects for Democracy and Social Justice." Femi Falana, a Lagos radical lawyer; Dr. Festus Iyayi, who took over the reign of ASUU boss from Dr. Tukur and Dr. Yussuf Bala Usman, former head of History Department and ex-lecturer ABU Zaria, will speak on the topic, while Comrade Ali Chiroma, former NLC


